About the societies

The International Lymphoedema Framework (ILF)

The ILF was established as a UK charity in 2009. The framework developed from a project aiming at bringing together the main stakeholders involved in the management of lymphoedema in the United Kingdom in 2002, but ILF rapidly spread to become an international project with an objective to support individual countries develop a long-term strategy for lymphoedema management. The ILF includes 15 national frameworks around the world, all working to improve the management of lymphoedema and related disorders worldwide.

The ILF believe:

- Patients should always be at the heart of the Framework Projects
- Only a collaborative and multidisciplinary partnership between all stakeholders, recognized as experts, can lead to an improvement in the management of lymphoedema
- Improving the management of lymphoedema is a dynamic process requiring ongoing research and implementation into practice
- International collaboration is essential

The Lymphoedema Wales Clinical Network

In April 2011, the Welsh Government allocated £1 million recurring to implement the Strategy for Lymphoedema in Wales published two years previously. The Strategy aims to enable all lymphoedema patients access to the appropriate services at the right place, right time and with the right person regardless of whether their lymphoedema is related to cancer or not.

The All Wales Lymphoedema Network Board has been established to maintain a strategic oversight of the Strategy for Lymphoedema in Wales. The Chair of the Network Board is Fiona Jenkins, Executive Director of Therapies and Health Sciences for Cardiff & Vale University Health Board.

The Network has been coordinated through a virtual network approach, for NHS Wales to:

- Oversee the planning of services for NHS Wales, ensuring recommendations in the Strategy are implemented locally;
- Oversee clinical education and training requirements for the network area;
- Advise on how Health Boards should respond to strategic developments as they arise;
- Provide the source of composite advice of Health Boards to Welsh Government when required; and
- Advise on allocation of funding as services change or as funding arrangements change.
- Individual Health Boards will remain responsible for the delivery of services locally, and Chief Executives will retain accountability for local service delivery.

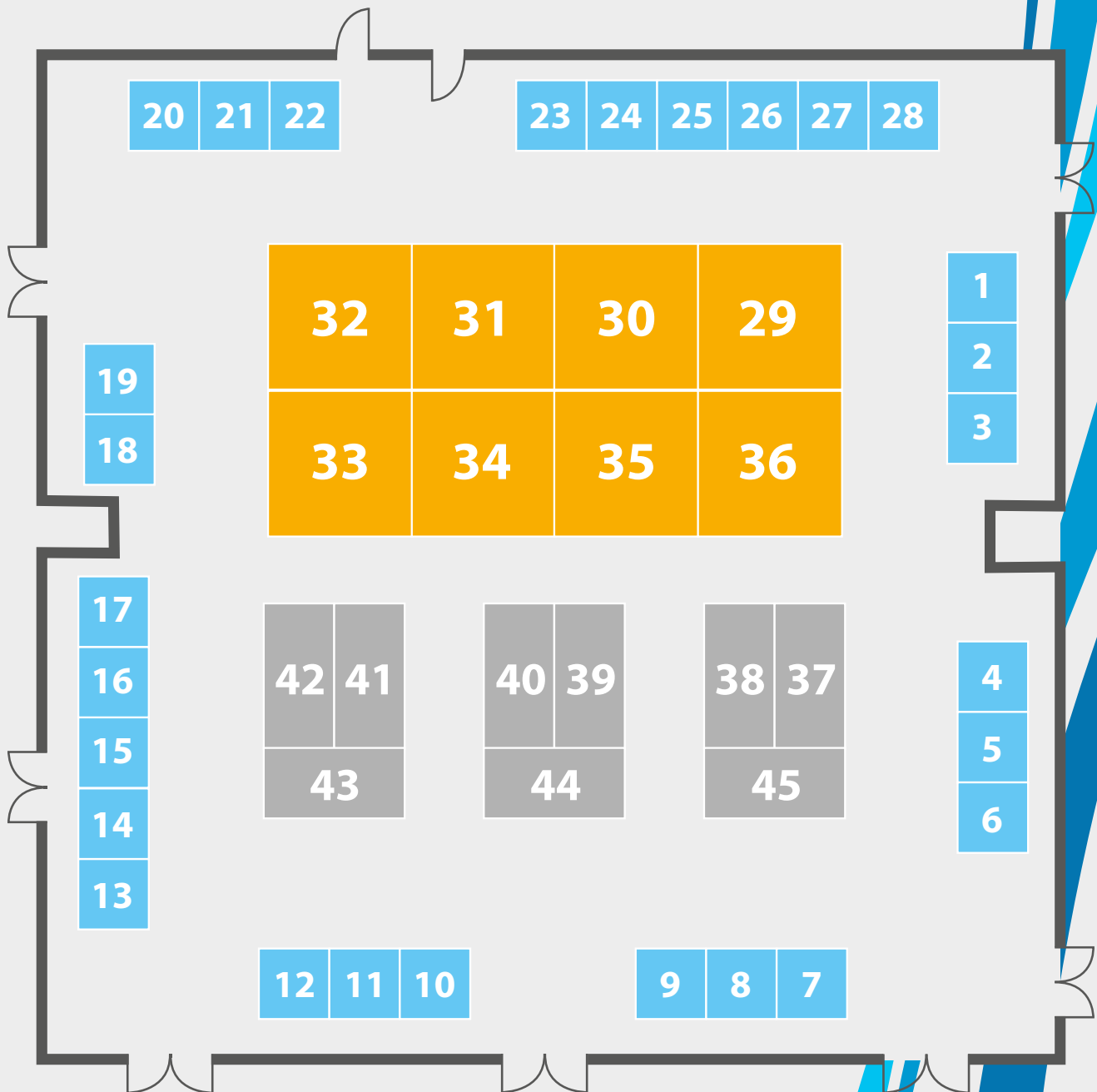

Terms and conditions

Education Partner

1. DEFINITIONS

In these Terms and Conditions, the term 'We' or the 'Organiser' shall mean Wound Care People (WCP), Wound Care Today (WCT) and any brand within our portfolio. The term 'Sponsor/Education Partner' means any company, organisation who has applied for an 'Education Partner Agreement', to include third party agencies, contractors and employees.

2. PAYMENT TERMS

For Education Partners full payment is due strictly within 30 days of invoicing, payment terms will be laid out on the invoice. If full payment is not received, we reserve the right to release the Agreement to another partner. Promotional activity will commence upon receipt of payment.

3. CANCELLATION

Cancellation of an Education Partnership Agreement must be made in writing and will be subject to 25% administration fee. Costs incurred in the execution of promotional activity to include production or management will be charged at 100%. Cancellation of attendance to an event is liable to charges and based on the following scale:

91 – 120 days	50% charge
90 – 61 days	75% charge
60 – 0 days	100% charge

Where part of the Agreement is cancelled any discounts given on the overall package will be forfeited.

4. TERMINATION AND WITHDRAWAL

Without prejudice to any other rights, we may terminate the Agreement by notice in writing if the Sponsor fails to observe and fulfil any of the terms of the Education Partner Agreement.

Specifically relating to Event Participation

1. DEFINITIONS

The 'Organiser' shall mean Wound Care People (WCP), Wound Care Today (WCT) or any brand within our portfolio. The 'Exhibitor' means any company, organisation or person who has applied to participate at the ILF conference. As part of that Agreement participates as an Exhibitor at the Organisers events, to include third party agencies, contractors and employees.

2. REVISION OF EXHIBITION FLOORPLAN

The Organisers reserve the right to revise the exhibition floorplan if it is believed such variation to be in the general best interests of the exhibition as a whole.

3. EXHIBITION STAND SPACE ALLOCATION

When Exhibition space has been offered, the Exhibitor is required to provide written formal acceptance of the area to form part of the Agreement. The Organiser reserve the right to accept or reject any application for an alternative site and control the type of exhibit proposed.

4. STAND CONSTRUCTION

All stands are sold with a basic shell scheme package, that will be arranged for the Exhibitor. Enhanced packages are available at an additional cost, which will also be arranged by the Organiser.

5. NON-ATTENDANCE

Where the Exhibitor fails to attend an exhibition, the Exhibitor will remain liable for full payment of the booked space and no reimbursement will be made. The Organiser reserves the right to re-allocate or otherwise utilise the space as they see fit.

6. PROHIBITION OF TRANSFER

Exhibitors may not assign, sub-let or grant licences in respect of the whole or any part of the space allocated to them without the permission of the Organisers.

7. PROTECTION OF EXHIBITS

All exhibits must be properly protected to avoid danger to any person or persons in attendance at the exhibition. The Exhibitor shall indemnify the Organiser against any claim or action through and injury or damage.

8. INSURANCE LIABILITY

The Organiser and the venue will not be responsible for the safety of any exhibit or property of any exhibitor, or any other person, for the loss or damage of, or destruction to the same, by theft, or fire, or any other cause whatsoever. The exhibitor

agrees and undertakes to insure in their full replacement value, the contents of their stand, and all associated ancillary equipment and materials. The exhibitor is responsible for providing their own public liability insurance and must provide evidence of their public liability insurance to Wound Care People Ltd no less than 30 days prior to the event.

9. POSTPONEMENT OR ABANDONMENT OF AN EVENT

The Exhibitor shall have no claim against the Organiser or its contractors in respect of any loss or damage caused by the prevention, postponement, or abandonment of the event for reasons beyond the control of the Organiser.

10. ADMISSION

Admission to the exhibition will be restricted to those persons who, in the opinion of the Organiser, have a legitimate, professional interest in the subject of the exhibition. The Organiser reserve the right to refuse admission to any person or persons to the exhibition without assigning any reason. Exhibitor passes above the inclusive allocation, will be subject to additional charge.

11. RIGHT OF REJECTION

Exhibitors are admitted to the exhibition and shall remain there, solely on strict compliance with these rules and regulations. the organisers reserve the right to prohibit in whole, or in a part, and reject any Exhibitor or their representative in the case of the failure to comply with the rules and regulations. There shall be no return of payment if such rejection or prohibition is deemed necessary by the Organiser.

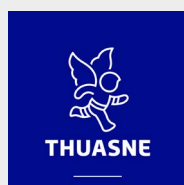
12. ADMENDMENT RULES

The description headings to these terms and conditions are merely for reference, and do not form part of the contract between the parties.
